Sub : Renewal of Essentiality certificate for starting Shri Ramkrishna Institute of Medical Sciences and Sanaka Hospitals at Malandighi, Durgapur, Burdwan.

Sir,

In terms of the delegation of power to the undersigned the essentiality certificate as requested by you is granted hereunder

1. No. of undergraduate medical teaching institutions already existing in the state : 17
2. No. of M.B.B.S seats available or No. of doctors being produced annually : 2450
3. Doctors Population ratio in the State : 1: 2600 (approx).
4. Now the establishment of MBBS College with 150 annual intake capacity would resolve the problem of deficiencies of qualified medical personnel in the State and improve the availability of such medical manpower in the State. Such action is absolutely necessary to cope up with the scarcity of doctors in the rural areas.
5. The restrictions imposed by the State Government, if any, on students who are not domiciled in the State from obtaining admission in the state to be specified -
The guidelines framed by the Supreme Court of India regarding admission of medical students to medical colleges will be adhered to in respect of this college. The students selected for the general quota, need to be domiciled in the state for a minimum period of ten years.
6. Full justification for opening of the proposed Medical College.
 - a) To cope up with the scarcity of qualified medical personnel in the rural areas of the state.
 - b) Optional utilization of the medical teaching infrastructure present in medical teaching institution concerned in respect of annual intake capacity of 150 students.
 - c) To achieve a favorable doctor population ratio in the long run (1 : 1000).
7. Doctor – Patients ratio proposed to be achieved : 1: 200.

The The Vice President, Sanaka Educational Trust, Durgapur has applied for the establishment of Shri Ramkrishna Institute of Medical Sciences and Sanaka Hospitals at Malandighi, Durgapur, Burdwan for MBBS course with 150 intake capacity. On careful consideration of the proposal the Government of West Bengal has decided to issue the necessary essentiality certificate for the establishment of a Medical College with 150 numbers seats.

It is further certified that –

- a) The Trust owns and manage a 300 bedded Hospital which is established in Malandighi, Durgapur since September '2015
- b) It is desirable to establish a medical college & Hospital in the public interest.
- c) Establishment of a Medical College & Hospital at Malandighi, Durgapur, Burdwan is feasible.
- d) Adequate clinical material as per Medical Council of India norms is – available.

It is further certified that in case the applicant fails to create necessary infrastructure for the Medical College as per M.C.I. norms and fresh admissions are stopped by the Central Government, the State Government shall take the responsibility of the students already admitted in the college with the permission of the Central Government.

P.T.O

The following shall be added in terms of Notification dated 31.01.2017 published in the Gazette of India :-

- e) The Sanaka Educational Trust own and possesses 20 Acres of land in vill : Malandighi, P.S : Kanksha on which non agricultural use of land is permitted and a Medical College/Hospital can be established on it.
- f) The building plan of the Hospital and Medical College has been approved by the competent authority, namely, Malandighi Gram Panchayat designated by the State Government for such purposes on 09/02/2012.(copy enclosed)
- g) The Hospital and Medical College have been*granted Completion Certificate/Building Use Certificate by the competent authority, namely, Malandighi Gram Panchayet designated by the State Government for such Purposes on 19/06/2017(copy enclosed).

This Renewal certificate is valid for 1(one) year from the date of its issue.
