- (2) No. of seats available or No. of doctors being produced annually:5350
- (3) No. of doctors registered with the State Medical Council: 74054
- (4) No. of doctors in Government service: 13,272
- (5) No. of Government posts vacant and those in rural/difficult areas:4,390
- (6) Doctor population ratio in the State: 1:1404

On careful consideration of the proposal, the Government of West Bengal has decided to issue **Provisional** Essentiality Certificate to the applicant for the recognition of Shri Ramkrishna institute of Medical Sciences & Sanaka Hospital to run with 250 numbers of MBBS seats.

It is certified that:-

(a) The institute has 900 (nine hundred) bedded multi specialty hospital equipped with the latest diagnostic and treatment facilities.

- (b) This Essentiality Certificate is valid for the academic year 2024-25 only subject to verification of documents.
- (c) Adequate clinical material as per the National Medical Commission norms is available.

It is further certified that in case the applicant fails to maintain infrastructure for the medical college asper NMC norms and fresh admissions are stopped by the National Medical Commission, the State Government shall take over the responsibility of the students already admitted in the College with the permission of the National Medical Commission.

- (d) Shri Ramkrishna institute of Medical Sciences & Sanaka Hospital possess 51 Acres of land.
- (e) The building plan of the Hospital and Medical College has been approved by the competent authority, designated by the State Government for such purposes only.

(f) The Hospital and Medical College have been granted Completion Certificate/Building Use Certificate by the competent authority.

Spl. Remarks: Thirty three per cent (33%) of the total seats (previous & new) in MBBS course shall be contributed under State Quota.
