Annexure I Details of Bond

The requirement of Bond applies ONLY to candidates allotted under either the State Quota or the Management Quota.

The financial value MUST be equivalent to the remaining tuition fees of the entire curriculum which is not paid at the time of admission.

A candidate shall submit the Bond by ANY ONE of the following two OPTIONS:

OPTION 1 — Bank Guarantee

A Bank Guarantee that meets ALL the following two mandatory criteria:

- 1. It must be in the prescribed format available on our webpage: https://srims.setgoi.ac.in/admission.html
 AND
- 2. Issued by any Scheduled Bank included in the Second Schedule of The Reserve Bank of India Act, 1934.

OPTION 2 — Affidavit

An Affidavit that meets ALL the following four mandatory criteria:

- 1.lt must be in the prescribed format available on our webpage: https://srims.setgoi.ac.in/admission.html
 AND
- 2.It must be executed on a ₹100 non-judicial stamp paper purchased in the candidate's name from the Court where this affidavit is being made,

 AND
- 3.lt must be sworn before a 1st Class Judicial Magistrate,
 AND
- 4. The place where it may be sworn is determined as follows:
 - o If the candidate's permanent residence is within the state of West Bengal, the affidavit may be sworn EITHER
 - (a) at Durgapur Court, Dist. Paschim Bardhaman, West Bengal, OR
 - (b) at the Court at candidate's place of permanent residence within West Bengal.
 - o If the candidate's permanent residence is outside the state of West Bengal, then the affidavit MUST be sworn ONLY at Durgapur Court, Dist. Paschim Bardhaman, West Bengal.
