Sir/Madam,

I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 2nd batch of 150 (one hundred and fifty only) MBBS students at Shri Ramakrishna Institute of Medical Sciences and Sanaka Hospitals, Durgapur, West Bengal u/s 10A of the IMC Act, 1956 for the academic Year 2020-2021.
