2. It is to inform you that your institution is fully responsible to fulfil and maintain norms including the infrastructure both physical and human resources, teaching faculty, clinical material and stipend to PG students similar to PG students of government colleges in the state etc.

throughout the academic year, as stipulated in regulation of National Medical Commission (NMC).

In case of false/wrong declaration or fabricated documents have been used for procuring permissions of MARB and any misconduct is brought to the notice of National Medical Commission (NMC) or **found during surprise assessment at any stage during the current academic year, your institution is liable, not to be considered for recognition of that degree.** This letter of permission will be revoked for the current academic year if such exigency arises. 4. It is mandatory by government medical colleges to contribute **15%** MBBS seats and **50%** of post graduate broad specialties (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the directions of Hon'ble Supreme Court.

5. It is mandatory to develop a website of medical college/institution and display all the information of college and courses offered as per the guidelines issued by National Medical Commission (NMC) from time to time.

6. This LOP is subject to confirmation of Bank Guarantee. If any discrepancy is found lateron in respect of any data/documents, the LOP shall be withdrawn immediately.
